SOLICITATION CHANGES/CLARIFICATIONS

1. Section 8. This section is changed as followed:

The successful contractor shall have at a minimum the following qualifications:

- A. License to do business ~~in the state of Kansas and~~ in the state of Missouri. If required, Contractor shall also be licensed to do business in Kansas City, Missouri.

PROPOSER QUESTIONS/REQUESTS FOR CLARIFICATION

1. Q: Do you have to be registered to do business prior to submitting your bid?

A: Registration with the state of Missouri would only be required when awarded the contract.

2. Q: If a personally owned vehicle is used for company operations, could it satisfy the Auto Liability requirement if the appropriate coverage and limits are documented?

A: You can use your individual vehicle as long as coverage meets the requirements.

3. Q: Would the \$1,000,000 Auto Liability and \$1,000,000 Umbrella/Excess Liability coverage need to be in place at the time our quotation is submitted, or may the selected contractor obtain or increase these coverages prior to contract execution and the Notice to Proceed?

A: Insurance is not required until prior to the Notice to Proceed.

4. Q: Since all the locations of service are in Kansas City, Missouri, is it required to be registered to do business in the state of Kansas?

A: At minimum, you would need to be registered to do business in the State of Missouri.

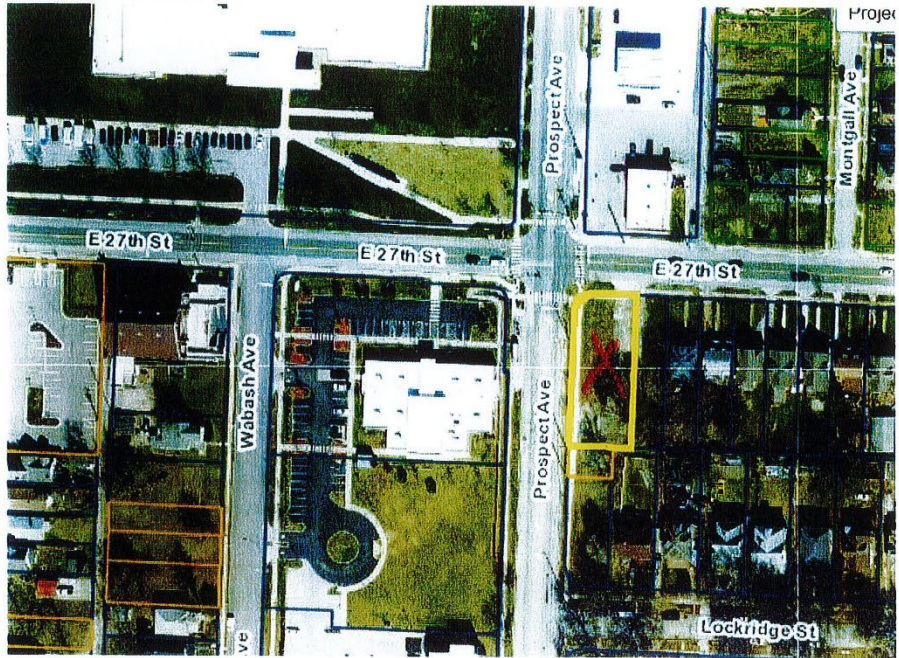
