A revised Price Proposal (Attachment C-1) is provided with this Addendum to correct errors and address Proposer questions below.

QUESTIONS FROM POTENTIAL FIRMS

1. Q: Can you please clarify the contract term? The cover letter references 1 + 4 years (5 total), while Section 2.2 references 4 + 3 years (7 total).

A: The contract will be for one (1) year, with four (4) one-year extension options.

2. Q: What is the anticipated annual spend or volume of work for each practice area?

A: Based on current needs, KCATA's estimated annual expenditure with outside legal counsel (by category):

- General Legal Services: \$ 30,000
- Employment & Labor: \$ 50,000
- Real Estate/Economic Development: \$150,000
- Intellectual Property \$ 10,000
- Federal/FTA Related Issues: \$ 5,000
- Workers Compensation Litigation: \$400,000
- Accident Litigation (includes Conflict): \$500,000
- Bond Counsel: \$150,000
- Board Counsel: \$ 75,000

3. Q: Attachment C-1, the pricing form, states "Proposers shall provide the billable hourly rates and number of hours of each individual (by position and name) to be assigned to KCATA legal matters". Can you please provide clarification on what is meant by "number" of hours?

A: This statement is an error. The revised Price Proposal form (Attachment C-1) is included with this Addendum.

4. Q: Attachment C-1 requests that we provide rates for each individual being proposed. Is KCATA open to receiving rates categorized by title and practice area? (For example, one rate for all Employment and Labor Law partners, one rate for all IP associates, etc.).

A: Yes. Please see the revised Price Proposal form (Attachment C-1) included with this Addendum.

5. Q: The Price Proposal (Attachment C-1) on page 55 says Page 1 of 2, however there is only Page 1. Please advise.

A: This document is one page. The Price Proposal has been revised.
